We, the undersigned, for the purpose of forming a membership corporation pursuant to the Membership Corporation Law of the State of New York, do hereby certify:

1. The name of the proposed corporation shall be "GREENE ROD AND GUN CLUB, INC."

2. The purposes for which it is to be formed are to advance the interests of sportsmen as a class, to increase friendliness between its members and to co-operate with the New York State Conservation Department and owners and occupants of land. To buy, sell and lease real estate for corporate uses and purposes.

3. The territory in which its operations are principally to be conducted is Chenango County, New York.

4. The Village and County in which its office is to be located are Village of Greene, Chenango County, New York.

5. The number of its directors shall be not less than five nor more than ten.

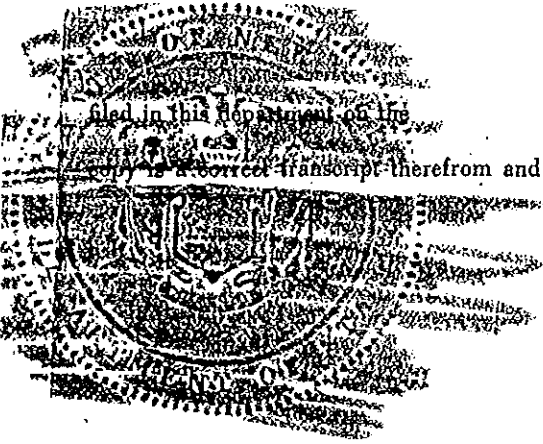
